AGENDA ITEM: III. Fundraising and Campaign Progress Report

ACTION REQUIRED: None

BACKGROUND: Philanthropic cash flow measures actual gifts received by the University during a specific fiscal year. It includes cash or cash equivalents received for philanthropic purposes; it does not include pledges or future support (bequest expectancies, annuities, etc.). Total commitments represent the combination of new commitments (new gifts, private grants, bequests, deferred gifts, donor-advised fund gifts, and non-binding commitments) and new future support (expectancies).

Through June 30, philanthropic cash flow for FY 2020 was \$389M, an increase of over 8% compared to the previous fiscal year. Total commitments for FY 2020 stood at \$531M; our fundraising goal for FY 2020 was \$500M. The University exceeded that goal by \$31M, or over 6%. In FY 2020, 96 commitments were made of \$1M+, including 17 gifts of \$5M+. Gifts of \$1M+ represented 59% of our total fundraising progress. A great accomplishment in light of the unusual circumstances caused by COVID-19.

In FY 2020, there were 123 new Bicentennial commitments of \$100K+ representing nearly \$101M. Future Support also continued to deliver steady commitments. In FY 2019, expectancies totaled \$137.9M and in FY 2020 that total was \$151.6M; a 10% increase.

The University continues to track ahead of schedule in campaign totals, and through August 19, campaign-to-date totals were at 3.1B, with 62% achieved against the overall goal of \$5B.

AGENDA ITEM: IV. Bicentennial Scholars Matching Fund Report/Discussion

ACTION REQUIRED: None

BACKGROUND: The Bicentennial Scholars Fund (the "Fund') was approved by the Board of Visitors as a \$100M Strategic Investment Fund request in December 2016. The program provided a 1:2 match for new endowed undergraduate scholarships that were established with gifts of at least \$100,000 (\$50,000+ for College at Wise scholarships) and fully paid within five years; scholarship gifts of \$1M+ were matched 1:1. The program was expanded in August 2018 with an additional \$100M and the program was modified where only new scholarship endowments that support need-based scholarships established at a minimum of \$1M were to be matched 1:1. The program was expanded to include graduate student support in December 2017.

As of August 13, 2020, the University has raised \$253M in commitments and pledges for Bicentennial Scholarships and those matching funds have leveraged almost \$170M in anticipated matching funds from the Strategic Investment Fund ("SIF"). The combined outside commitments and internal matching funds have created 318 new scholarship endowments across Grounds at the undergraduate and graduate level for a total impact of \$423M.

<u>**DISCUSSION**</u>: President Ryan will report on the breakdown of matching-fund commitments to-date for graduate scholarships, undergraduate need-based scholarships, undergraduate merit scholarships, and athletic scholarships. As part of that report, President Ryan will address suggested modifications to the Bicentennial Scholars Fund.
