- a. SOM Tuition: Proposed 3.5% tuition increase for BIMS and MPH, 2% tuition increase for first year in-state medical students, 4% for out-of-state
 SON Tuition: Proposed 3.5% tuition increase for all graduate programs; undergraduate tuition will continue to be base plus differential for BSNs
- b. Endowment Distribution: The BOV approved a decrease in the distribution rate from 5.01% in FY22 to 3.62% for FY23, which partially offsets the increase in market value
- c. Gifts: One-time gifts received in FY22 are not expected to be replicated in FY23
- d. SOM Expense: Growth primarily driven by increase in the UFM tax, which is partially offset by growth in subvention.
