**DISCUSSION:** Philanthropic cash flow measures actual gifts received by the University during a specific fiscal year. It includes cash or cash equivalents received for philanthropic purposes; it does not include pledges or future support (bequest expectancies, annuities, etc.). Total commitments represent the combination of new commitments (new gifts, private grants, bequests, deferred gifts, donor-advised fund gifts, and non-binding commitments) and new future support (expectancies).

Through May 6, 2022, and with only two months remaining in the final quarter of FY 2022, philanthropic cash flow was \$376M, and total commitments stood at nearly \$490M.

Due to the generosity of our alumni, parents, and friends, the University continues to track ahead of schedule in our fundraising totals for the *Honor the Future* campaign. On April 28, 2022, the University publicly announced that fundraising progress for the campaign had crossed the \$4B threshold, with over 81% achieved against the overall goal of \$5B.
