


Annual Strategic and Capital Planning Process




Proposed 2017 Multi-Year Capital Plan

- 2017 proposed plan revises 2016 Capital Plan to include new projects, remove projects that are no longer a priority, and align high-priority projects across timeframes based on when project will be initiated:
 - Near-term currently in progress and/or expect to expend resources within next 12 months
 - Mid-term to be initiated during 2018-20
 - Long-term to begin after June 30, 2020
- All projects not likely to be fully funded and/or construction completed within the six-year timeframe
- Aligns with State-required Six-Year Capital Plan

Capital Construction Expenditures 2007-16 (in millions)






2017 Multi-Year Capital Program by Fund Source¹

2017 Multi-Year Capital Program by Fund Source¹






Pro-forma Debt Capacity
