# B.3. RESOLUTION FOR EXCLUSION OF CERTAIN DIRECTORS AND OFFICERS — SEPTEMBER 2023

WHEREAS, current Department of Defense Regulations contain a provision making it mandatory that the Chair of the Board, a Senior Management Official, and a Facility Security Officer meet the requirements for eligibility for access to classified information established for a contractor facility security clearance; and

WHEREAS, said Department of Defense Regulations permit the exclusion from the personnel of the requirements for access to classified information of certain members of the Board of Directors and other officers, provided that this action is recorded in the public Minutes;

RESOLVED, the Rector as Chair of the Board, Senior Management Official, and Facility Security Officer at the present time do possess, or will be processed for, the required eligibility for access to classified information; and

RESOLVED FURTHER, in the future, when any individual enters upon any duties as Rector of the Board, Senior Management Official, and Facility Security Officer, such individual shall immediately make application for the required eligibility for access to classified information; and

RESOLVED FURTHER, the following members of the Board of Visitors and other officers shall not require, shall not have, and can be effectively and formally excluded from access to all *CLASSIFIED* information disclosed to the University and shall not affect adversely Board and University policies or practices in the performance of classified contracts for the Department of Defense or the Government contracting activities (User Agencies) of the National Industrial Security Program.

#### C.2 COMMENDING RESOLUTION FOR WHITTINGTON W. CLEMENT

WHEREAS, Whittington Whiteside Clement, of Richmond, took a B.A. in History from the College of Arts & Sciences in 1970, and a J.D. from the School of Law in 1974; and

WHEREAS, Mr. Clement is a member of the Alumni Association Board of Managers, has co-chaired the Parents Committee, was a founding member of the College's Alumni Council, and has served on the Jefferson Scholars National Selection Committee. He is a member of Omicron Delta Kappa and the Raven Society; and

WHEREAS, Mr. Clement is a former partner, and now special counsel, in the law firm of Hunton Andrews Kurth LLP. He served as the Virginia Secretary of Transportation for Governor Warner from 2002 to 2005. Prior to joining the Warner Administration, Mr. Clement was a partner in the Danville law firm of Clement & Wheatley P.C. and a member of the Virginia General Assembly for 14 years. During his tenure as a legislator, he chaired the higher education capital outlay subcommittee of the Appropriations Committee. He served on the State Council of Higher Education for Virginia (SCHEV) for 10 years and as its chair from 2009-2011. He is a former president of the Virginia Bar Association and past chair of the Virginia Chamber of Commerce Board of Directors; and

WHEREAS, Mr. Clement was appointed to the Board of Visitors by Governor McAuliffe in 2015 and he was reappointed by Governor Northam in 2019. He was elected vice rector for two years and then served as Rector of the University from July 1, 2021 until the end of his term on June 30, 2023; and

WHEREAS, Mr. Clement served on the Academic and Student Life, Buildings and Grounds, and College at Wise committees before becoming Rector. As Rector, he was exofficio on all standing committees and chair of the Executive Committee; and

WHEREAS, Mr. Clement's accomplishments as Rector are many, including leading the University to normal operations after the pandemic; opening the "best in class" Student Health and Wellness Center; supporting tuition transparency and multi-year forecasting for predictability and planning purposes; championing student self-governance including the

Honor System; and encouraging and supporting free speech and free expression across the political and ideological spectrum; and

WHEREAS, a trusted resource on myriad issues, Mr. Clement has enthusiastically mentored those who sought his guidance, both young and old; and

WHEREAS, as a son of Southside Virginia and a lifelong community advocate, Mr. Clement dedicated his time both personally and professionally to improving the economies of both Southside and Southwest Virginia;

RESOLVED, the members of the Board of Visitors thank Whittington W. Clement for his exemplary service to the Commonwealth and to the University, consider him a friend and valued colleague, and hope and expect that he will continue to be engaged in the work of the University; and

RESOLVED FURTHER, his colleagues on the Board wish Whitt and Meg Clement and their three sons Whitt, Harrison, and John, continued success and happiness in all of their future endeavors.

# C.3 COMMENDING RESOLUTION FOR LOUIS S. HADDAD

WHEREAS, Louis Samuel Haddad, of Suffolk, was recruited to Armada Hoffler in 1985 as an on-site construction superintendent, became President of Armada Hoffler Construction Company in 1987, and in 1996, he was promoted to President of Armada Hoffler Holding Company, the parent of all Armada Hoffler entities, inclusive of the flagship development division as well as asset management. WHEREAS, Mr. Haddad was appointed to the Board of Visitors by Governor Northam in 2019 and served for four years; and

WHEREAS, Mr. Haddad served with distinction on the Academic and Student Life, Buildings and Grounds, Finance, and Audit, Compliance, and Risk Committees; and

WHEREAS, Mr. Haddad provided invaluable guidance and construction industry expertise to the University's architects and construction management teams; educated members of the Board on market forces at play during an unprecedented run-up in

construction-related inflation; and spoke eloquently about the University's need to take advantage of opportunities to build significant buildings that will enhance the University's architectural legacy; and

WHEREAS, Mr. Haddad was a strong advocate for the University's sustainability goals and the strategies to attain those goals;

RESOLVED, the members of the Board of Visitors thank Louis Samuel Haddad for his exemplary service to the Board and to the University, consider him a friend and valued colleague, and hope and expect that he will continue to be engaged in the work of the University; and

WHEREAS, Ms. Hucles Mangano previously served as president of the Women's Sports Foundation, founded by Billie Jean King, and regional director of Up2Us Sports. She founded Empowerment Through Sport, a sports and leadership organization for collegiate and elite-level female athletes entering the workplace; and

WHEREAS, Ms. Hucles Mangano was appointed to the Board of Visitors by Governor Northam in 2019, serving for four years; and

WHEREAS, Ms. Hucles Mangano served on the Academic and Student Life, Advancement, and College at Wise Committees during her tenure on the Board; and

WHEREAS, Ms. Hucles Mangano provided unique insights and wise counsel on many student matters, particularly those involving athletics and student athletes;

RESOLVED, the members of the Board of Visitors thank Angela Hucles Mangano for her dedicated service to the Board and to the University, consider her a friend and valued colleague, and hope and expect that she will continue to be engaged in the work of the University; and

# **Clayton S. Rose**

Clayton Rose is the Baker Foundation Professor of Management Practice at the Harvard Business School (HBS). From 2015 until 2023, he served as president of Bowdoin College. Prior to Bowdoin, beginning in 2007, he was a member of the HBS faculty, teaching and writing on issues of leadership, ethics, the Global Financial Crisis, and the role of business in society. He spent the first 20 years of his career in finance, retiring as the vice chair at J.P. Morgan, having run several global divisions of the bank and where he was a member of its senior management team. He earned his undergraduate degree and MBA from the University of Chicago. In 2003, following his business career, he enrolled in the doctoral program in sociology at the University of Pennsylvania to study issues of race in America, earning his master's degree in 2005 and his PhD with distinction in 2007. He has served on a number of corporate boards and is currently a director of the Bank of America where he chairs the Enterprise Risk Committee. He also chairs the board of trustees of the Howard Hughes Medical Institute, the nation's largest private funder of basic biomedical research with a \$24 billion endowment.
