Commonwealth Initiative on K-12 Computing Education

- Computing skills and digital literacy are foundational elements of success in contemporary society
- Such skills need to be a focus of pre-K-12 education
- New Virginia K-12 Standards of Learning require all students to receive training in computer science
- Current efforts are incomplete, lacking resources (curriculum, teacher supports) and expertise
- The UVA Commonwealth Initiative on K-12 Computing Education designed to address these gaps



Gaps in the Present Infrastructure in K-12 Computer Science Education

- The mandate is broad and fairly general, leaves a lot up to local divisions
- Considerable unevenness in divisions capacity and implementation
- Lacking a set of recommended curricula, activities, and training for teachers to implement curricula effectively
- CodeVA is one example of an effort to address gaps provides experiences for students and training for teachers
- Critical need for a large-scale effort to reach across the Commonwealth and address gaps



UVA Commonwealth Initiative on K-12 Computing Education

A comprehensive and evidence-based clearinghouse and training resource for K-12 teachers and educators, providing state-wide opportunities for:

- 1. Ongoing teacher learning experiences and professional development in CS education
- 2. Development of targeted CS teacher education certificates and endorsement programs
- 3. Instructional resources, activities and curricula for inquiry- and design-based student learning experiences, stand-alone and integrated CS, in both formal and informal contests, at pre-K–20 levels
- 4. Connections for Industry partnerships and collaborations for students and educators
- 5. CS education research and grant funding

UVA Commonwealth Initiative on K-12 Computing Education Outcomes

Five-year plan to develop, evaluate, and distribute resources in all school divisions, all grades statewide; outcomes include:

- Certificates for teachers in K-12 computer science education available across the Commonwealth through higher education partnerships
- Competency assessments and credentials in computer science for students
- Open source, curated library of effective instructional resources for K-12 students
- Best practices network of K-12 educators
- Ongoing implementation, evaluation, and quality control across the Commonwealth



Resources

- Five year plan for development, implementation, quality assurance: \$2,500,000
- Includes support for:
 - Program director
 - Staff support for outreach and resource development
 - Design group
 - Platform development, evaluation, distribution
 - Educator stipends
- \$500K annual investment beginning in FY 19 20 through FY 23 24
- Current year (18-19) pilot activities funded with Curry seed support and NSF grant funds
- Other resources provided through Federal and sponsored mechanisms; approximately \$1 million/year



UVA Commonwealth Initiative on K-12 Computing Education

- A critically important element of the Commonwealth's strategy for economic and social development
- Current lack of resources and focus likely to lead to weak and highly unequal results
- Addresses key gaps in curricula, educator training, certification and credentialing, partnerships
- Open source, publicly available, networked in partnerships to sustain long-term

WELL-BEING: Having financial security, safety, housing, food, mental health, nourishing relationships, and being able to do what matters to them



Depression Rates


Chronic Opioid Prescription Rates













