Mr. Payne called on Mr. Luellen to give a campaign progress report.

## Fundraising and Campaign Progress Report

Philanthropic cash flow measures actual gifts received by the University during a specific fiscal year. It includes cash or cash equivalents received for philanthropic purposes; it does not include pledges or future support (bequest expectancies, annuities, etc.). Total commitments represent the combination of new commitments (new gifts, private grants, bequests, deferred gifts, donor-advised fund gifts, and non-binding commitments) and new future support (expectancies).

Philanthropic cash flow for FY23 was in excess of \$300M, and total commitments stood at more than \$500M.

Due to the generosity of alumni, parents, and friends, the University continues to track ahead of schedule in *Honor the Future* campaign totals, and to-date totals are \$4.77B, against the overall goal of \$5B. The campaign will continue until June 30, 2025, even if the \$5B goal is reached earlier.

Mr. Luellen said Advancement-sponsored events continue to be very popular, and most all of them have an online component, which has significantly increased participation. Campaign participation rates have grown to 18%; social media presence has helped grow participation rates. Advancement Operations have improved, and Mr. Luellen gave credit to director Julie Featherstone for this improvement, processing 140,000 gift transactions a year. Last year, the error rate was  $1/10^{\rm th}$  of 1%--best practices is a 1% error rate.

Mr. Luellen spoke about labor shortages and challenges with filling positions. Advancement vacancy rates went up to 30% during the pandemic, but are now down to about 10%, which is within the normal range.

The Bicentennial Scholarship Program has created 575 different scholarship endowments, with 75 created with gifts of \$1M or more. The total impact, with University matching funds, has exceeded \$600M. By the end of the campaign, we hope to exceed \$750M.

Mr. Luellen announced some hires involving Virginia Athletics: Kevin Miller will be the new executive director of the Virginia Athletics Foundation, and Wally Walker will return to the University as the Deputy Athletics Director focused on revenue.

Mr. Ryan added to the comments about the importance of the scholarship endowment matching program and said a few words about the initiative to raise funds to endow faculty chairs. He spoke also about a newer initiative to endow University Professorships at \$10M each, with \$5M from a donor and an equal matching from the University. This initiative has been very successful. In two years, six have been endowed, and the goal is to create ten in all.

Mr. Ryan announced the pledge from Mr. Ramon Breeden of \$25M to the McIntire School of Commerce and \$25M to the Virginia Athletics Foundation. Both gifts are for their building programs. Mr. Breeden and his wife, Lucy, attended the meeting, and Mr. Breeden spoke about why he chose to make these generous gifts to the University. He said he developed his business acumen and confidence at the McIntire School, and it has had a huge impact on his life. He said Barry Parkhill has been a long-term advocate for supporting Athletics, so he decided to include Athletics in his gift.

Mr. Ryan gave Mr. Breeden a baseball jersey because he tried out for the baseball team but had to quit to take three jobs in order to support himself. He spoke about this experience, and how he wouldn't have traded it for the world because he learned so much.
