# Minutes of the June 6-7, 2024, Board of Visitors Meeting

Following the Health System Board, Academic and Student Life Committee, and the Advancement Committee meetings of the Board of Visitors, the Board met as the full Board in open session at 3:02 p.m. on Thursday, June 6, 2024. Robert D. Hardie, Rector, presided. Open session was streamed live.

The Rector called the meeting to order and explained the reasons behind the altered schedule for this meeting. The Rector had an unavoidable conflict on Friday morning and the President had a conflict that would cause him to miss two hours of the Friday afternoon sessions. There was also a conflict on Friday involving another member of the Board.

# <u>Discussion with University Leadership</u>

President Ryan welcomed everyone and thanked them for their flexibility in holding the leadership discussion on Thursday versus Friday. He thanked the departing Board members Jim Murray, Tom DePasquale, Mark Bowles, Elizabeth Cranwell, Babur Lateef, and faculty representative Tish Jennings, for their time on the Board. He said their individual contributions have been invaluable, and as a group, they have helped lead the University through both tragedy and triumph. He welcomed the new student representative, Lisa Kopelnik, a rising fourth-year student.

President Ryan explained that in the Leadership session he has traditionally addressed three agenda items: a piece of good news, a challenge, and an item for feedback from the Board. The good news: recruitment and retention of top faculty. Some great successes recently include two in the Medical School, the retention of neuroscientist John Lukens and the hiring of biomedical engineer Evan Scott who will begin later in the summer. Second, the challenge. As university leaders or as parents, the delay in federal financial aid from the U.S. Department of Education has caused a host of issues for colleges and universities across the country. Vice Provost for Enrollment Stephen Farmer was asked to join the discussion to talk about what it has meant for UVA and how it has affected the incoming class. The item for feedback is related to the new Pan-University Entrepreneurship Initiative, led by Darden professor Michael Lenox. Mr. Lenox will give an overview of the program after Year 1, and then pose a few questions to the Board as the University continues to refine and develop efforts to strengthen entrepreneurship at UVA, especially as the Manning Institute ramps up.

Dr. Melina Kibbe, dean of the School of Medicine, introduced Mr. Lukens and Mr. Scott, who both spoke about their research endeavors and their excitement about the future of research at the University. Mr. Scott will be the director of Nanostar, developing different drugs through nanotechnology. He will have a joint appointment in the School of Medicine and the School of Engineering. Mr. Lukens is a researcher and Director of the Harrison Family Translational Research Center for Neurodegenerative and Alzheimers Disease. Both centers will both be housed in the Paul and Diane Manning Biotechnology Institute.

Mr. Farmer and Mr. Stephen Kimata, director of Student Financial Services, briefly explained the many issues with the rollout of the new version of the Free Application for Federal Student Aid (FAFSA) which was launched with delay and with technical errors. This has created anxiety and uncertainty for many families of applicants to the University this year. The FAFSA has been streamlined which is great, but the rollout has been terrible. The problems have knocked many students off the path to college. Whether that is temporary or permanent is unknown. UVA's College Advising Corps has been trained to help students with FAFSA, so UVA has a better record than some others. The Advising Corps will help any Virginia student with completing the FAFSA. Mr. Farmer explained all the ways UVA Student Financial Services has pivoted over the last few months to meet the needs of newly admitted students.

Mr. Lenox led a discussion about UVA's Pan-University Entrepreneurship Initiative. He said universities are investing in venturing for several mission-driven reasons: 1) education – inspiring the next generation of entrepreneurs and innovators and promote a culture of integrity, mutual respect, excellence, collaboration, and innovation; 2) commercialization – moving discoveries from the laboratory into the world to enable discoveries that enrich and improve lives; 3) economic development – helping surrounding communities and regions flourish and to make UVA synonymous with service. Lead economic development through academic discovery and entrepreneurship; and 4)

engagement – connecting alumni, faculty, students, and community to cultivate the most vibrant community in higher education.

This initiative started in September, but it has been a journey for at least 25 years. The last nine months have been spent on meeting with over 100 stakeholders (students, faculty, staff, entrepreneurs, alumni, community leaders). In December, there was a gathering of over 24 stakeholders to engage in a design thinking exercise to consider opportunities. In January, they created "tiger teams" specific to students and faculty to begin executing on concepts, and in April began implementing three quick wins (student "club house," founder concierge service, and biotech accelerator). Mr. Lenox said he hopes to launch the three quick wins this Fall and begin pursuing longer term opportunities, including: the Solutions Labs, the Solutions Building on Emmett-Ivy; and Commonwealth Partnerships.

Following Mr. Lenox's outline of entrepreneurship initiatives, he opened the floor to comments, questions, and opportunities that might be available to UVA. A lively discussion ensued about entrepreneurial successes and failures, and whether a student can learn to be an entrepreneur or if it is a talent some people have innately, and others do not.

# **Closed Session**

At 4:10 p.m., Dr. Long read the closed session motion, and after approving the motion, the Visitors met in closed session. Ms. Susan G. Harris was present for the closed session.

"Mr. Rector, I move that the Board of Visitors go into Closed Session to consult with legal counsel and receive legal advice about specific legal and regulatory matters including potential and actual litigation, negotiations and legal settlements, and privileged reviews of actions that are the subject of criminal and civil proceedings, where discussion in a public meeting could adversely affect the negotiating and litigating posture of the University; to discuss and consider elections, appointments, promotions, salaries, resignations, and retirements of academic faculty and administrators and to conduct the annual evaluation of the president; and to discuss actions by University officials to protect the safety and security of persons on and around the Grounds of the University. The relevant exemptions are Sections 2.2-3711 A (1), (7), (8) and (19) of the Code of Virginia."

At 4:55 p.m., the Board resumed in open session, and, on motion by Dr. Long, which was duly seconded, certified that the deliberations in closed session had been conducted in accordance with the exemptions permitted by the Virginia Freedom of Information Act. Ms. Harris called the roll, and all members present voted in the affirmative: Mr. Hardie, Mr. Blue, Mr. Bowles, Mr. Brown, Ms. Cranwell, Mr. DePasquale, Mr. Ellis, Mr. Harris, Dr. Lateef, Dr. Long, Mr. Manning, Mr. Murray, Mr. Nau, Mr. Payne, Ms. Pillion, Ms. Sheridan, and Mr. Wetmore. The certification motion was as follows:

"I move that we vote on and record our certification that, to the best of each member's knowledge, only public business matters lawfully exempted from open meeting requirements, and which were identified in the motion authorizing the Closed Session, were heard, discussed or considered in Closed Session."

The Board recessed for the day.

# **COMMENDING RESOLUTION FOR PATRICIA A. JENNINGS**

WHEREAS, Patricia "Tish" A. Jennings took a bachelor's degree from Antioch College in 1977, a masters of education from Saint Mary's College in 1980, and a doctorate from the University of California Davis in 2004; and

WHEREAS, Professor Jennings is a recognized leader in the fields of social and emotional learning and mindfulness in education and a Professor of Education in the School of Education and Human Development; and

WHEREAS, Professor Jennings led the team that developed CARE, a mindfulness-based professional development program shown to significantly improve teacher well-being, classroom interactions and student engagement, and most recently Professor Jennings received a sizeable grant from the U.S. Department of Education for Project ENGAGE, which is an \$8M study to develop and evaluate a scaling model for CARE involving 66 elementary schools across Virginia and Kentucky. She is a co-author of Flourish: The Compassionate Schools Project curriculum, an integrated health and physical education program and is co-Investigator on the Compassionate Schools Project, a large \$11M randomized controlled trial to evaluate the curriculum's efficacy; and

WHEREAS, Professor Jennings served as the chair of the Faculty Senate for the 2022-2023 academic year, and as the faculty representative to the Board of Visitors for the 2023-2024 academic year; and

WHEREAS, as faculty representative, Professor Jennings has been an invaluable resource on matters affecting the faculty and a compassionate sounding board for Visitors;

RESOLVED, the Board of Visitors thanks Professor Patricia A. Jennings for her exceptional service and wise counsel to the University and the Board, considers her a trusted friend and colleague, and wishes her happiness in all of her future endeavors.

Mr. Murray read the memorial resolution for Visitor Emeritus Thomas Bliley. On motion, duly seconded, the memorial resolution was approved by unanimous voice vote.

#### MEMORIAL RESOLUTION FOR THE HONORABLE THOMAS J. BLILEY JR.

WHEREAS, the Honorable Thomas J. Bliley Jr., a native of Richmond, Virginia, took a bachelor's degree in political science from Georgetown University in 1952 and served in the Navy from 1952 to 1955; and

WHEREAS, Mr. Bliley was a man of faith with a strong commitment to public service; and

WHEREAS, Mr. Bliley worked in the family business, Bliley's Funeral Homes, to become a third general President of the company. During this time, he was also elected to Richmond City Council, including serving as Mayor for seven years; and

WHEREAS, in 1980, Mr. Bliley was elected to the U.S. House of Representatives where he was known for his signature bow tie and gentlemanly manners. He served for twenty years including as chairman of the House Energy and Commerce Committee, and authored or co-authored a number of important bills, including what later was known as the Gramm-Leach-Bliley Act. He retired from the House in January 2001; and

WHEREAS, Mr. Bliley was affiliated with many civic organizations including the Knights of Malta, the Richmond Rotary, and the Knights of Columbus; and

WHEREAS, Mr. Bliley served on the Board of Visitors from 2000 to 2004. He was a trusted resource to the other members on federal and state government matters; and

WHEREAS, The Honorable Thomas J. Bliley Jr. passed away on November 16, 2023;

RESOLVED, the members of the Board of Visitors commend the life and devoted service of Thomas J. Bliley Jr., mourn his passing, and express their deepest condolences to his wife Mary Virginia Kelley, his children and their spouses, his grandchildren and great grandchildren, and his many friends.

# **Remarks by the Rector**

The Rector said this is the final meeting for five members who have all served for eight years. They will be recognized formally in September. He took a few moments to acknowledge their extraordinary work as members of this Board:

- Mark Bowles, who chaired the Committee on the College at Wise. He pushed the Committee on the College at Wise to convene at Wise this spring, which was an enlightening trip. The Rector said he hoped every member of the Board would make an effort to go to Wise—the College has been a significant asset to the Commonwealth and to the University. He also thanked Mr. Bowles for lending his state government expertise to the Board and said it has been invaluable.
- Elizabeth Cranwell, who championed the College at Wise and the work UVA is doing in Southwest Virginia as the chair of the College at Wise committee, and then moved on to take the reins of the Committee on Academic and Student Life. Rector Hardie said she has been a strong and vocal advocate for more effective advising services for students, and she has worked hand in glove with the Provost's office and others to implement improvements. She has consistently been a strong voice for students, both at UVA and Wise, and her legacy will be long lasting.
- **Tom DePasquale**, who has also been an amazing advocate for the College at Wise. He was recognized this year with the Crockett Award, which is given to a person in the UVA community who has gone above and beyond to support the work of the College. In addition, as chair of the Audit, Compliance, and Risk Committee, Mr. DePasquale has led the Board through some significant challenges, and the Board appreciates his efforts.
- **Dr. Babur Lateef**, who has chaired both the Audit, Compliance, and Risk Committee and the Health System Board. The Rector said we appreciate Dr. Lateef's work in both areas, particularly his significant time on complex Health System matters, from joint ventures to faculty issues. The past few years have

been ones of growth and change for UVA Health, and Dr. Lateef has met the challenges.

• **Jim Murray**, who served as rector for two years including during the pandemic, as well as vice rector and chair of the Finance Committee. Mr. Murray has been a true leader of the Board, and his work on UVIMCO and with the financial areas of the University are especially notable. He also championed the Karsh Institute and the University's work on democracy, and many other areas. Mr. Hardie said we owe Mr. Murray a huge debt of gratitude and will greatly miss his wise counsel.

# Remarks by the Student Representative

Ms. Lisa Kopelnik, student representative to the Board, gave the following remarks.

Thank you, Mr. Rector, and good afternoon to everyone.

It is such an honor to join this Board and to share a seat at this table with you, a table that shapes the present and future of our university for generations to come. And it is such a privilege to represent the students of the University of Virginia who are the heart of this place and are the reason why I love this university so much.

Before I get started, I wanted to extend my immense gratitude to the outgoing student member, Lillian Rojas. Lillian is one of the most dedicated student leaders I have ever worked with, and the level of care she showed this position is truly admirable. Even amidst division and challenge, Lillian served with grace, a deep sense of compassion, and duty to our community. I have had the privilege of learning from her this last year as she went above and beyond in her responsibility to represent and listen to students of all backgrounds, and I hope to carry her legacy forward in doing the same. Thank you Lillian for your service and for your friendship.

Coming from the San Francisco Bay Area (not to be confused with the equally esteemed Chesapeake Bay Area), my first day at UVA was my move in day. I remember parking near Madison Hall and walking with my parents and younger brother to see the rotunda in person for the first time (I had only seen various Google images at that point). I was completely in awe of how beautiful and how green UVA is, and I felt and continue to feel extremely lucky to call this place my home. A few days later at convocation was when I truly began to understand what it means to be a UVA student – to be a part of the UVA family, to understand our history, to be intellectually curious, and what has most shaped my experience here – to participate in the tradition of student self-governance.

Convocation is where I learned about the University Judiciary Committee, where I just completed my term as Chair in my third year. As Chair of the Judiciary Committee, I had the privilege of running the committee tasked with upholding our standards of conduct in the service of safety, freedom, and respect at UVA. In that role, I worked with so many different students and organizations who came through our process, led outreach efforts to the broader uva community about student self-governance, and also had the privilege of working with the many students who devote their time to improving the university community. I had the privilege of working in partnership with Student Affairs and the Policy Accountability and Critical Events Team, addressing the real time needs of students and understanding the policies that this University is built upon. This position exposed me to the many challenges that students face – issues of mental health, stress, and lack of resources. But it also empowered me to really believe in my peers- to believe in our student judges, counselors, and investigators, to believe in students who actively worked to repair their relationship with the university after causing harm. Being chair also put me in the distinguished category of just a few people who can name each of our 12 standards of conduct in order.

As we find ourselves in a pivotal time for higher education, I am deeply honored and excited to serve in this position—where I above all seek to represent, listen to, and advocate for all students. As I navigate this role, I have three main areas of focus that I hope to advance: 1) civil discourse and dialogue across differences; 2) student opportunities; and 3) student safety and wellbeing.

To me, at the core of a liberal arts education is the ability to critically think and engage with people with a sense of mutual respect. It is the ability to appreciate differences in perspectives and to create an environment where students feel comfortable expressing their opinions and equally willing to listen to others. What I have appreciated most about my time here is the ability to have those difficult and nuanced conversations with my peers, which is why dialogue across differences is a sincere passion of mine. I feel grateful to have experienced this in my majors – Politics Honors and Economics – and I truly believe the culture of civil discourse is in many ways what makes UVA special, and we have to work to ensure this value does not erode.

Especially as we enter the next year, I hope to use my position to bring students and faculty together to experience productive dialogue and exchange ideas that can translate into material actions. There are so many incredible partners in this work in Student Affairs, the Karsh Institute, Center for Politics, Interfaith Student Center, Blue Ridge Center, and the

list goes on, but I am excited to forward student-driven initiatives with other student leaders and community members in the service of civil discourse.

I am also passionate about connecting students with the incredible opportunities and resources that UVA has to offer, and working to build more opportunities and resources to promote socioeconomic diversity at UVA. As students, we are deeply excited about the remarkable progress made by the expansion of Access UVA and the commitments that UVA has made to support first generation and low income students. As student member, I look forward to connecting with students to better understand how the university can provide material support while on Grounds to ensure that every student has access to the same opportunities while here. Many students have expressed challenges with participating in high-cost extracurricular activities or time-consuming and unpaid activities, and I look forward to expanding awareness about the already available resources such as the Cavalier Fund while working to build more ways for students to have access to the funding and support they need to make the most of their UVA experience. Financial support and funding for extracurriculars, internships, and costs of living will enhance the student experience here, as will the improvements made by the advising system that may offer students non-financial resources that are essential to success.

Finally, it is a priority of mine to address concerns of student safety and wellbeing. As Chair of the UJC, I saw firsthand how issues of safety affect everyday life here, including students' ability to feel comfortable in their own homes and when walking around the area. Anecdotally, I have heard of students finding it difficult to access the necessary mental health resources on grounds, and I hope to continue to build on the university's commitment to fulfilling this need. I look forward to the continuing university-wide conversations on safety and mental health, and to meeting with students to understand their experiences related to this issue.

I am truly honored and excited to represent the student body of the University of Virginia and to work with all of you to achieve the goals and visions we have for this University. I deeply appreciate the opportunity to uplift this tradition of student self-governance, and to make a difference in this place that has already given me so much. Thank you.

# **Remarks by the Faculty Senate Chair**

Rector Hardie said Michael Kennedy, Professor in the School of Education and Human Development and chair of the Faculty Senate, will make his final remarks as the chair of the Faculty Senate. On July 1 he will assume the position of faculty representative to the Board.

Mr. Kennedy said the new Faculty Senate chair is Mr. Jim Lambert, who is a distinguished researcher and scholar in the School of Engineering. Ms. Jeri Seidman is the chair-elect of the Faculty Senate. She is a faculty member in the McIntire School of Commerce.

Mr. Kennedy spoke about a major change to the Senate's bylaws to add all appointed, salaried faculty to the Senate, which includes faculty working in the library and elsewhere. They have added two Senate positions.

He made brief comments about the protest supporting divestment from firms that do business in Israel and in support of the people of Gaza. The protest culminated in the clearing of a tent encampment on May 4. The Faculty Senate passed a resolution calling for an independent investigation and turned down a resolution condemning the actions of the University around the protest.

# **Closed Session**

Rector Hardie said the closed session is a continuation of the full Board closed session from yesterday. At 3:50 p.m., Mr. Murray read the closed session motion, and after approving the motion, the Visitors met in closed session. Ms. Susan G. Harris was present for the first part of the closed session. Mr. Ryan joined for the second part, and the Executive Vice Presidents, the Chief of Staff, University Counsel, Mr. Jeffries, and Mr. Martel were present for the third part of the closed session.

"Mr. Rector, I move that the Board of Visitors go into Closed Session to consult with legal counsel and receive legal advice about specific legal and regulatory matters including potential and actual litigation, negotiations and legal settlements, and privileged reviews of actions that are the subject of criminal and civil proceedings, where discussion in a public meeting could adversely affect the negotiating and litigating posture of the University; to discuss and consider elections, appointments, promotions, salaries, resignations, and retirements of academic faculty and administrators and to conduct the annual evaluation of the president; and to discuss actions by University officials to protect the safety and security of persons on and around the Grounds of the University. The relevant exemptions are Sections 2.2-3711 A (1), (7), (8) and (19) of the Code of Virginia."

At 5:20 p.m., the Board resumed in open session, and, on motion by Mr. Murray, which was duly seconded, certified that the deliberations in closed session had been conducted in accordance with the exemptions permitted by the Virginia Freedom of Information Act. Ms. Harris called the roll, and all members present voted in the affirmative: Mr. Hardie, Mr. Blue, Mr. Brown, Ms. Cranwell, Mr. DePasquale, Mr. Ellis, Mr. Harris, Dr. Lateef, Dr. Long, Mr. Murray, Mr. Nau, Mr. Payne, Ms. Pillion, Ms. Sheridan, and Mr. Wetmore. The certification motion was as follows:

"I move that we vote on and record our certification that, to the best of each member's knowledge, only public business matters lawfully exempted from open meeting requirements, and which were identified in the motion authorizing the Closed Session, were heard, discussed or considered in Closed Session."

# **Final Session**

Mr. Hardie reminded the members of the Board that the action items were presented in committee except as otherwise stated.

WHEREAS, 1914 Law alumnus Burkett Miller directed the provision of \$1M to create the White Burkett Miller Professorships in 1975 with matching support from the Commonwealth's Eminent Scholars Fund; and

WHEREAS, the Board of Visitors established the White Burkett Miller Professorship in Government and Foreign Affairs in 1978; and

WHEREAS, gift documentation does not specify that the chairholder's title must include "Government and Foreign Affairs," and the professorship has supported concurrent chairholders with varying titles over the years; and

WHEREAS, the White Burkett Miller Professorship Fund has grown substantially since its establishment and is capable of supporting up to three chairholders at once;

RESOLVED, the Board of Visitors renames the White Burkett Miller Professorship in Government and Foreign Affairs as the White Burkett Miller Professorship in Public Affairs and affirms that up to three chairholders may be concurrently elected as chairholders subject to vetting and approval by the Office of the Provost and election by the Board of Visitors.

# 6. MARY ANN PITTS JEFFERSON SCHOLARS FOUNDATION DISTINGUISHED PROFESSORSHIP IN MATHEMATICS

WHEREAS, President James E. Ryan's current salary places him in the 42nd percentile of presidents of peer public institutions and in the 26th percentile of all peers, public and private; and

WHEREAS, in consideration of his length of service and high performance, the Board of Visitors has determined that President Ryan should be compensated at approximately the 75<sup>th</sup> percentile for public peers and the 50<sup>th</sup> percentile for all peers;
